Menu of Services and Fees

In accordance with the Fee Policy of Friday's Child Adoption Services, Inc. the following is a description of services and the corresponding fees:

<u>Interviews With Birth Parents</u> – to help work through feelings and issues related to placing the child for adoption, their awareness of alternatives to adoption, adoption procedures and opportunities for placement with more than one adoptive family.	\$110 per hr
<u>Information and Referral/Application</u> - providing basic information to prospective adoptive parents about the adoption process, review and approval of the application documents by the executive director, development of a service plan and administrative services prerequisite to formal acceptance as an agency client.	\$295
<u>Orientation and Training</u> – consisting of a minimum of three didactic workshops focused on the issues of adoption and involving child development and family specialists, other adoptive parents and presentations on the culture of the proposed sending country	\$150
<u>Adoptive Home Study</u> consisting of a minimum of three face-to-face interviews with the adoptive applicant and other relevant parties to: 1.verify compliance with medical and legal requirements of the Commonwealth of Virginia, the U.S. Bureau of Citizenship and Immigration Services and the government of the sending country, 2. assess the experience, attitudes and preparedness for parenting and 3.make a determination and recommendation as to the general suitability of the home as an adoptive placement.	\$1,375
<u>Expedited Adoptive Home Study</u> are home studies done on an accelerated basis under circumstances that require a final report to be completed in 4 weeks or less.	\$1,500
<u>Home Study Update</u> consisting of one face-to-face interview in the adoptive applicant's home and re-verification of supporting documentation and the family's circumstances.	\$600
<u>Simultaneous Meeting</u> – with birth and adoptive parents subsequent to the exchange of written information between the parties but prior to the recommendation to the court regarding the suitability of the placement	\$275

Foreign Agency Liaison Services – related to identifying available children and securing legal, medical and social information on the child for evaluation by an approved applicant. \$1,500

Domestic Agency Adoption Fee - consultation with agency holding custody of children relative to placement with approved families. This may include separate documentation for the Interstate Compact on the Placement of Children or for out-of-State courts or attorneys. \$1,000

Post-placement Supervision consisting of in-home visits to: \$350 per visit

1. determine the success of the placement
2. serve as a resource for identifying and resolving any problems that might arise, either directly or by referral to an appropriate service provider
3. meet the requirements of the Commonwealth of Virginia preliminary to action by the Court granting a Final Order of Adoption and,
4. in the case of inter-country placements, fulfill the requirements for re-adoption in Virginia as well as the requirements of the government of the sending country

Report of Investigation - preparation of the summary report to the court and The Commissioner of Social Services upon receipt of an Order of Reference preliminary to the granting of a Final Decree of Adoption. \$300

Counseling Services – provided to any of the parties to address issues related to placement or subsequent adjustment and/or delays or disruptions that may occur. \$110 per hour

Extraordinary Documentation - Additional fees may apply for services not listed above but requested by the client. Completion of forms unique to specific agencies and/or creation of specialized documentation will be billed on an hourly basis \$110 per hour

Fees are generally non-refundable but may be waived or reduced at the discretion of the agency’s executive director. Fees are due and payable at the time that the service is rendered.
